For those of you unable to go, the attendance at our joint meeting with ASCE in September set a new record. The meeting included a guided tour of one of the largest NHDOT construction projects in the state, which helped boost the attendance to 102. The 102 registrants included 42 ASCE members, 26 guests or presenters, 4 students and 30 SENH members. By way of comparison, our typical SENH stand alone meeting attendance ranges from 40 to 60.

The lack of attendance by SENH members was disappointing and no doubt the poor economy is somewhat to blame. In addition to lower meeting attendance, SENH is also experiencing a lack volunteerism. This lack of volunteers affects what we can do as an organization and is directly reflected in the lack of content in this month's newsletter.
